SENATOR DIANNE FEINSTEIN AND THE SANCTUARY CITY

Have you noticed how Senator Dianne Feinstein (D) has seemed to back away from the idea that San Francisco’s sanctuary city status is a good thing?

Funny thing about Ms. Feinstein’s attitude is, she is the reason that San Francisco is a sanctuary city. Recall, in 1989, Mayor Feinstein signed San Francisco Administrative Code Chapter 12H: Immigration Status. This code states, in part: “... the City and County of San Francisco is a City and County of Refuge.”

The code goes on to state that “No department, agency, commission, officer or employee of the City and County of San Francisco shall use any City funds or resources to assist in the enforcement of federal immigration law or to gather or disseminate information regarding the immigration status of individuals in the City and County of San Francisco ... “ and that “The prohibition set forth in this Chapter shall include, but shall not be limited to:

(a) Assisting or cooperating, in one's official capacity, with any Immigration and Naturalization Service (INS) investigation, detention, or arrest procedures, public or clandestine, relating to

alleged violations of the civil provisions of the federal immigration law.

(b) Assisting or cooperating, in one's official capacity, with any investigation, surveillance or gathering of information conducted by foreign governments, except for cooperation related to an alleged violation of City and County, State or federal criminal laws.

(c) Requesting information about, or disseminating information regarding, the immigration status of any individual, or conditioning the provision of services or benefits by the City and County of San Francisco upon immigration status, except as required by federal or State statute or regulation, City and County public assistance criteria, or court decision.

(d) Including on any application, questionnaire or interview form used in relation to benefits, services or opportunities provided by the City and County of San Francisco any question regarding immigration status other than those required by federal or State statute, regulation or court decision. Any such questions existing or being used by the City and County at the time this Chapter is adopted shall be deleted within sixty days of the adoption of this Chapter.

“The Human Rights Commission shall review the compliance of the City and County departments, agencies, commissions and employees with the mandates of this ordinance in particular instances in which there is question of noncompliance or when a complaint alleging noncompliance has been lodged.”

So you see, the code is specific and has real teeth. Any city worker who ignores this risks their job.

And as for Ms. Feinstein, she has said nothing about how she would change this law. Perhaps in 1989 there was a good reason for this but today? I think it’s time to take action and end sanctuary cities and for congress to withhold funds from all sanctuary cities.
