Carl Burton was honored on March 11, 2014 when Supervisor Susan Peters appointed him as her alternate on the Area 4 Agency on Aging.

Area 4 Agency on Aging develops and coordinates policy serving the aging community in Nevada, Placer, Sacramento, Sierra, Sutter, Yolo and Yuba counties acting to implement the Older American Act, originally passed by Congress in 1965. The Agency advocates on behalf of older individuals and estimates there are over 390,000 seniors living in the service area.

built both the U.S. and California economies to their once famous prominence,” says Martin.

“The lack of economic and personal freedom thereof has greatly hindered the prosperity of California and our nation.”

Martin was born in Lodi, and raised on his grandfather’s farm.

From an early age, he learned the value of money. He was first employed by his grandfather who wanted him to cut hay with a \$75,000 swather, a task which he says was absolutely daunting at such a young age.

“I have always remembered this experience as an early lesson in responsibility and accountability – a challenge I was willing to take.”

At one time, Manuel even started his own jelly company. Martins’ Jellies specialized in the production of pomegranate jellies and was carried in over ten groceries stores, including Whole Foods.

Martin is not running for Assembly district 9 because he wants to, he feels compelled to.

“The current government cannot seem to stop infringing on the private sector’s economic and civil liberties, whether it be in manufacturing, agriculture, or retail.

The bureaucrats in Sacramento will not leave entrepreneurs alone to create jobs, to provide for their families, and to supply goods and services to society. This over-reaching government needs to be stopped.”

## APPOINTMENT

A4AA identifies needs of the elderly, and creates plans for meeting those needs through a system of in-home and community services to enable people to maintain their independence and dignity and administers federal, state, local, and private funds to support those services.

Last year the budget for A4AA was \$9.1 million with over 42% of the budget spend on nutrition programs (such as meals on wheels).

This year (2014) my appointment by President George W. Bush as a delegate to the White House Council on Aging comes to a close and a few years ago I served the Sacramento community as President of Senior and Senior Organizations.

Back in the early part 2000’s the California Republican Party, at my urging, passed a platform plank dealing with the aging community that reads in part “Californians who have retired, or are close to retirement, should be free from worry that resources they have built through their own work will be siphoned off by inflation or government action. We support laws that would prevent state or local governments from increasing property taxes on personal residences after owners reach 65. We oppose state taxes on Social Security income. The California Republican Party is committed to promoting opportunity for aging citizens to enjoy their retirement with the means they have accumulated throughout their working lives.”

## NEWS YOU MIGHT HAVE MISSED

The Justice Department reports that at Least 35% of people eligible for Obamacare's Medicaid expansion have criminal histories.

The President, and other Obamacare supporters assert that the reason why tens of millions of Americans go without health insurance is because these people have pre-existing conditions. The truth is less than a million Americans lack health insurance because of a pre-existing condition. Approximately 10 million Americans are uninsured because they are convicted criminals.

The Congressional Budget Office estimates that half of Obamacares expansion of coverage would come from expanding Medicaid. And it turns out that more than a third of the U.S. population eligible for the Medicaid expansion are ex-cons. In 2011, the U.S. Department of Justice estimated that “at least 35 percent of new Medicaid eligibles under the Affordable Care Act will have a history of criminal involvement.”

A front-page story in the New York Times said Medicaid’s “most important benefit,” according to corrections officials, “is that inmates who are enrolled in Medicaid while in jail or prison can have coverage after they get out. People coming out of jail or prison have disproportionately high rates of chronic diseases,

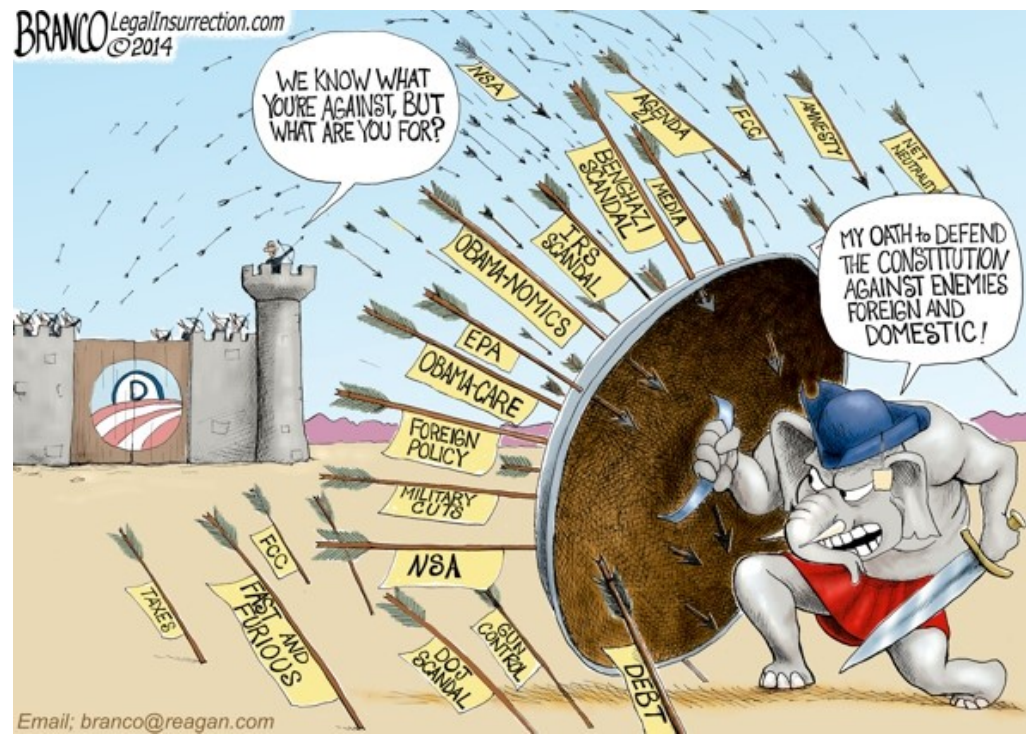
