Fox News announced Wednesday (March 16) that the network has cancelled the Republican presidential primary debate scheduled for March 21st in Salt Lake City, after Donald Trump said he would not attend and Sen. Marco Rubio dropped out of race for President.

Donald Trump said he would be speaking at the American Israel Public Affairs Committee on March 21. AIPAC said Trump is confirmed to

speak at its annual conference about American policies on Israel.

And today a strategist for Ohio Governor John Kasich issued a statement indicating that the Ohio governor would skip the debate unless Trump reversed his decision.

# **FREE SPEECH**

Sometimes the concept of free speech is called into question. Example, Terminiello v. Citv of Chicage. This is a leading case where a Catholic priest, Arthur Terminiello, who was fiercely anti-communist, gave a "fiery" speech in Chicago and was arrested for inciting a riot when more than 1,000 protesters disrupted him and ended by trashing the auditorium. Terminiello was arrested for violation of Chicago's "breach of peace" ordinance, found guilty of disorderly conduct and fined \$100. Eventually, the U.S. Supreme Court granted him a hearing and reversed his conviction, saying:

This years elections are looming large in Sacramento. We have the race for U.S. President and Senator race, plus all the members of House of Reprehensive will be voted on and members of California State Legislature.

There will also be a number County Boards of Supervisors, City Council and School Board members.

California voters need to be aware of existing laws that will affect them when casting their votes to make sure their vote is counts.

For your vote to count, you must be registered to vote 15 days prior to the election, so don't delay! Here is the information you need to know before you hit the polls and vote. You must meet the following criteria to register:

- You are a United States citizen
- You are a resident of California
- You are at least 18 years of age (or will be by the date of the next election)
- You are not in prison or on parole for conviction of a felony
- You have not been judged by a court to be mentally incompetent.

You will need to re-register to vote when:

- You move
- You change your name
- You change your political party affiliation.

As an American citizen one of your fundamental rights is to vote for our leaders.

And when I was first able to register to vote I had to be 21 years old and then I had to fill out a paper form.

But now you can register to vote when you're 17 years old if you will be 18 by the date of election.

This year Primary Election is on June 7, 2016 and in order to vote in the Presidential election you must be a registered Republican voter.

We still can't vote on-line but you can register to vote online. That's right anyone who is a citizen can use their computer and visit the California Secretary of State and register to vote online. Simply go to http://www.sos.ca.gov/ elections/voter-registration

Now no one has an excuse not to register to vote.





alternates to the national convention pledged to the candidate who receives a plurality of votes in that district.

Bylaws of the California Republican Party in Section 6.01 states:

SELECTION OF PRESIDENTIAL NOMINATING CONVENTION DELEGATES (A) The selection of Presidential Nominating Convention Delegates to the **Republican National Convention** shall be conducted as provided in Chapter 2 of Part 1 of Division 6, commencing with section 6300, of the California Elections Code: provided, however, Presidential Nominating Convention delegates and alternate Presidential Nominating Convention delegates shall be chosen by the Presidential candidate who obtained the plurality of Republican votes within each Congressional district, and, for Presidential Nominating Convention delegates and alternate Presidential Nominating Convention delegates "at large," by the Presidential candidate who obtained the plurality of Republican votes statewide.

Most older people who have "settled down" want to stay in their own homes for as long as they can. If you agree, chances are you've got a lot of company!

In Carmichael alone, there are now nearly 17,000 people age 60 and older. For Sacramento County as a whole, that number is closer to 265,000 people (18% of the entire population) and growing daily.

Whether older people (defined as any person over the age of 60) actually can stay in their own homes is quite complicated. While government can and does play a role in helping people "Age in Place," government was never intended to play the only role. Like Social Security and Medicare, Meals on Wheels and other federally-funded programs for seniors were designed to complement the role of the family, not to replace it.

Moving forward, we must all work together to maximize limited public dollars and to discover new ways to help people of all backgrounds and all income levels live at any age with choice and with self-reliance. That's why Agency on Aging\Area 4 (a nonprofit, nonpartisan joint powers organization) community board members, Carl Burton, Dr. Jayna Karpinski-Costa, Maxine Krugman and Miko Sawamura are holding Senior Citizens meetings in each Supervisor District. These meetings are free and open to the public, but space is limited. Anyone interested in attending should call the Agency

on Aging to reserve their seat in advance at 916-486-1876. Input received at these meetings will help shape key decisions made by board members about what types of services are funded in Sacramento County and to whom those services will be directed as of July 1, 2017.
